Such manpower will be part of total manpower to be provided by the Service Provider in case he gets the contract against this bid.

9. Payment

- 3. Service Provider must enroll all their employees in the statutory compliance like EPF, ESI and oth er similar Authorities and ID Card of the same should be issued to all enrolled employees. Also copie s of the same shall be produced for our office record.
- 4. Service Provider must issue salary slip every month to all enrolled candidates with deductions aft er the salaries are disbursed.
- 5. Service Provider must ensure proper replacement of the Sanitation Service Personal on the occasi on of any leave or dismissal or resignation of the deputed persons.

- 6. Service Provider shall submit the documentary proof of distribution of salary / wages to employee s on or before 7th of every next month.
- 7. Sanitation Service Person shall work for 5 days a week and 8 hours a day.

- 8. Equipment's such as PPE Kits Shoes including Uniform, raincoats and jerseys, as required s hall be provided to the Sanitation Service Person deputed by the Service provider.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
