The Service Provider is required to have at least 30 % of the required manpower on service provider's payroll for at least one year. 9. Payment

1. Service Provider shall have registered office in the State of Nagaland with valid PSARA Licence from Ho me Department, Govt. of Nagaland and provide First level contact details.

2. Service Provider must enrol all their employees in their Rolls and issue Statutory identity cards/Personal ID Cards.

3. Service Provider must enrol all their employees in the statutory compliance like EPF, ESI and other simil ar Authorities and ID Card of the same should be issued to all enrolled employees. Also copies of the same shall be produced for our office record.

4. Service Provider must issue salary slip to all enrolled candidates with deductions.

5. Service Provider shall submit the documentary proof of distribution of salary / wages to employees on or before 7th of next month.

6. Security Personnel shall work for 7 days a week and 8 hours a day. Securities shall work on all three shif ts /day without Arms.

7. Equipments such as headgears, torches, lathis, Shoes including raincoats and jerseys, whistle etc. , as required shall be provided to the Security Personnel deputed by the Service provider.

8. Service provider shall submit the record of attendance / Biometric attendance of employees along with c laim of monthly bill with your GST Number and previous month EPF and ESI Returns.

9. Security and safety of the Premises is the responsibility of the service provider/Security Personnel deput ed. Any theft/missing will be viewed seriously and reported to the nearest Police Station.

10. Service provider and employees shall provide undertaking that they maintain the integrity and confidentiality of the services being rendered by MSME Development & Facilitation Office, Dimapur.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditons stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
